Digital transformation is the process of using digital technologies to create new — or modify existing — business processes, culture, and customer experiences to meet changing business and market requirements."



Client Documents and Workpapers

- Filing Cabinets with Paper Folders for Each Client
 - Tagged for Each Year's Workpapers
 - Print Outs of Tax Returns and Financial Reports
 - Copies of Receipts and Check Stubs
- Mapped Server Drives with Client Folders
 - One Folder for Each Year's Workpapers
 - PDFs of the Tax Returns and Financial Reports
 - Limited Scanned Materials

Nothing Indexed/Searchable. Digital and Physical File Retrieval Was a Laborious Process.







Client Correspondence and Information Gathering

- Mailed engagement letters with return envelopes
- Mailed income tax preparation proformas
- Mailed forms of formal communications
- Emails for informal communications
- Phone Calls
- Mailed Flash Drives for Document Exchange (Including QuickBooks Backup Files)







Client Account Management

- No democratized, meaningful workflow solution
- No standardized process
- No standardized collection of client information
- No client-specific management/procedure documentation

Strategies and Solutions that Democratize Information





Liberating Data from Paper – Parsing Solutions

With minimal (or no) human involvement parsing solutions:

- Step 1: Recognize the characters on an image (Optical Character Recognition – OCR)
- **Step 2:** Assess strings of symbols or numbers, leveraging machine learning to:
 - Identify types of information (e.g., vendor name, payment totals, sub-totals, addresses, phone numbers, dates, etc.)
 - Reference vast online databases to analyze and interpret information
- **Step 3:** Determine the appropriate account coding, job assignments and departmental assignments, leveraging:
 - Past coding activity
 - User-level preferences and settings
 - Admin/user-defined rules







Liberating Data from Paper – Parsing Solutions

Examples of Solutions that Leverage Parsing Technologies

- Bookkeeping Automation (e.g., Dext, Bookkeep, A2X, etc.)
- Expense Applications (Expensify, Divvy, Tallie, etc.)
- General Ledger Solutions like QBO with Receipt Capture
- Banking Institutions (e.g., for Mobile Check Deposits)
- AR and AP Automation Solutions (e.g., Bill.com, AvidXchange, Tipalti, etc.)
- File Management/Storage Solutions (e.g., Liscio, Canopy, One Drive, SharePoint, Google Drive, etc.)







Liberating Data from Location Drives

- Microsoft SharePoint with Business One Drive or G Suite
 - If Using Microsoft, Couple with Microsoft Teams
 - If Using G Suite, Couple with Slack
- Dedicated File Management Solutions
 - Box
 - DropBox, etc.
- Client Interfacing File Collaboration
 - Liscio
 - ClientHub
 - ShareFile, etc.
- Displace Your Local Server with a File Management System and Use Private Cloud Options for Desktop Applications







Liberating Data from Voiced Interactions

- Good: Log Calls into a CRM
- Better: Use VOIP with Auto-Call Transcription
- Best: Use Softphones integrated with both
 Transcription Services and CRM for automatic
 logging of calls and, if you prefer, recordings





Tip: Solutions like Chorus.ai will analyze transcribed calls for leading indicators, commonly requested services, and quality assurance triggers.





Liberating Data from People (i.e., Brains)

- Good: Shared One Note or Evernote
- Better: CRM Solution with Comprehensive Client Information Capture
- Best: Workflow Solution that Contains
 - Standardized Processes Templates that are the Baseline for
 - All Client Productions Including Technology You Leverage for Production
 - Firm Operations
 - Client Specific Deployment of Templates with Client Specific Variances



Tip: Solutions like Bloomfire are designed to capture and capitalize the knowledge of people within the organization!
